

## CARES Act HEERF Reporting Disclosure – October 8, 2020 – FINAL REPORT

Boise Bible College – Department of Education – CARES Act – Higher Education Emergency Relief Fund (HEERF) Section 18004 Reporting Disclosure

As provided for by the Department of Education (DOE) as a provision of the CARES Act, Boise Bible College has received funds and distributed those funds to students to assist them with emergency financial relief related to the disruption of campus operations due to the coronavirus. These grants are intended to be used by students for food, housing, moving, course materials, technology, health care, childcare, and other costs relating to the campus closure.

Boise Bible College signed the Certificate and Agreement for these funds provided for under Section 18004(a)(1) on May 13, 2020 and these funds were allocated to Boise Bible College from the DOE in two installments, on July 17 and July 21, 2020.

Boise Bible College received a total of \$130,055 from the DOE for this portion of the program. The DOE has required institutions to use no less than 50% of the total funds received from Section 18004 provision to go directly to students to provide emergency relief as described above.

Eligible students were required to log into their personal accounts and complete a form to request funds. They could request up to \$900 prior to September 1, 2020.

On September 3, 2020 Boise Bible College had sent checks totaling \$65,028 directly to 73 eligible students who certified that they had needs and met the eligibility criteria. *This represents 100% of the funds allocated under Section 10884(a)(1).* The average student grant amount was \$890.79.

Eligible students are U.S. Citizens, were enrolled at least part-time in on-campus classes during the Spring 2020 semester, eligible to receive Title IV aid (<https://studentaid.gov/understand-aid/eligibility/requirements>) and had expenses due to disruption of campus operations. All eligible students were contacted directly by email, phone calls, texts and/or personal conversations.
